The cyber actors utilize socially engineered spear phishing emails to steal email account information, reset passwords, develop the target's networks, and collect information against the target. During this meeting, Shammari says the US Embassy in Baghdad was a "spies nest" which was fomenting soft war by organizing people in Iraq to question practices such as Arbaeen and Hajj. Many hardline Iranian media outlets argued that the fact that anti-Iranian protests in Iraq broke out in October, right before Arbaeen, means that the US sought to break apart the Shia world.
